The Seventh Framework Programme (FP7)

FP7 is the short name for the Seventh Framework Programme for Research and Technological Development. **FP7 is the EU's main instrument for funding research in Europe** and it will run **from 2007 to 2013**. FP7 is also designed to respond to Europe's employment needs and competitiveness. FP7 supports research in selected priority areas - the aim being to make, or keep, the EU as a world leader in those sectors. FP7 is made up of 4 specific programmes: **Cooperation**, **Ideas**, **People**, **Capacities**, plus a fifth specific programme on nuclear research.

Under the programme “**Cooperation**”, research support will be provided to international cooperation projects across the European Union and beyond. In 10 thematic areas, corresponding to major fields in science and research, the programme will promote the progress of knowledge and technology. Research will be supported and strengthened to address European social, economic, environmental, public health and industrial challenges, serve the public good and support developing countries.

The “**People**” programme offers individuals the opportunity to follow a career in research. European researchers should be encouraged to stay in Europe whilst at the same time the best researchers in the world should be attracted by European research excellence and infrastructures.

Building on the positive experiences with the “**Marie Curie Actions**”, the “People” programme should encourage individuals to enter the profession of researcher; structure their research training by offering options; and, encourage mobility within the same sector. The programme is designed to support regional research-driven clusters and at the same time unlock the research potential in the EU’s convergence and outermost regions. Support is to be provided for horizontal actions and measures underlining international cooperation. Finally, European society and science should be brought closer under the initiatives of the “Capacities” programme.
